CONTEST TRACKS: HAWTHORNE, REMINGTON, SANTA ANITA & TURF PARADISE. THE CONTEST WILL TAKE PLACE IN **FONNER KENO & THE CLUBHOUSE** – **1ST RACE IS 1:25 P.M. FROM HAWTHORNE. COMPLIMENTARY BEER AND SNACKS WILL BE AVAILABLE FOR CONTESTANTS.**

TWO TIERED ENTRY FEE: \$25.00 (PRIOR TO 10/25/09) - \$35.00 (DAY OF CONTEST) THAT GOES INTO THE PRIZE POOL FOR DISTRIBUTION TO THE TOP 5 FINISHERS, PLUS \$150.00 FOR YOUR WAGERING BANKROLL ACCOUNT. TOTAL COST AT TIME OF OFFICIAL REGISTRATION IS \$175.00 or \$185.00. REGISTER AT THE KENO COUNTER ANYTIME DURING REGULAR BUSINESS HOURS, BEGINNING ON MON OCT 5TH. ENTRY FEE INCLUDES A SIMULCAST PROGRAM AND P.P.'S FOR THE FOUR CONTEST TRACKS. **THE CONTEST IS STRICTLY LIMITED TO THE FIRST ONE HUNDRED (100) PAID ENTRANTS. THE ENTRY FEE IS NON-REFUNDABLE.**

FORMAT: HAW – REM – S.A. – TUP LIVE CARDS ARE THE TRACKS FOR THIS CONTEST. CONTESTANTS MAY WAGER ANY PORTION OF THEIR CURRENT ACCOUNT BALANCE ON ANY OF THE MUTUEL POOLS OFFERED ON ANY OF THESE RACES ON OCT 25TH. PLAYER'S STANDINGS ARE DETERMINED BASED ON CURRENT ACCOUNT BALANCES THAT ARE UPDATED AND POSTED ON DESIGNATED TELEVISION MONITORS. PLAYERS KEEP ANY MONEY WON FROM THEIR RESPECTIVE WAGERS.

RULES GOVERNING THE OCT 25, 2009 HANDICAPPING CONTEST

1. CONTEST IS STRICTLY LIMITED TO THE FIRST 100 (ONE HUNDRED) PAID ENTRANTS. ENTRIES WILL BE ACCEPTED BEGINNING MON OCT 5TH AT THE KENO COUNTER DURING REGULAR BUSINESS HOURS.
2. AS PER IRS REGS, EACH ENTRANT MUST HAVE A COMPLETED W-2G ON FILE TO ALLOW ANY W-2G WINNINGS TO BE CREDITED IMMEDIATELY TO YOUR ACCOUNT BALANCE. THIS W-2G WILL BE RETURNED TO YOU IN THE EVENT THAT IT IS NOT REQUIRED TO BE FILED.
3. \$150.00 IS THE REQUIRED BEGINNING ACCOUNT BALANCE AND NO FUNDS MAY BE ADDED TO THE ACCOUNT OTHER THAN VIA WINNING WAGERS. DUE TO COMPUTERIZED ACCOUNTING RESTRICTIONS, NO ACCOUNT FUNDS MAY BE WITHDRAWN UNTIL THE CONCLUSION OF THE FINAL CONTEST RACE.
4. IF YOU WISH TO WITHDRAW YOUR BALANCE, PLEASE DO SO AT THE SAME KENO WINDOW THAT PROCESSED YOUR ENTRY.

8. CONTEST WAGERS MUST BE MADE AT DESIGNATED CONTEST MUTUEL WINDOWS ONLY, WHICH WILL BE LOCATED IN KENO.
9. WAGERS MUST BE PLACED ON THE RACES FROM ANY OR ALL OF THE FOUR TRACKS ONLY BUT THERE IS NO RESTRICTION ON THE AMOUNT OR TYPE OF WAGER(S) ON THE RACE. THE AMOUNT OF THE WAGER(S) IS ONLY LIMITED TO THE BALANCE IN YOUR ACCOUNT.
10. STANDINGS ARE BASED ON ACCOUNT BALANCES AND WILL BE UPDATED AND DISPLAYED ON DESIGNATED TELEVISION MONITORS.
